
# Is it time to take your professional career to the next level?

Fellow membership is awarded to Accounting Technicians Ireland's most experienced Members. As a Fellow of the Institute of Accounting Technicians Ireland, you can use the letters FIATI to differentiate your senior experience and expertise within the accounting profession.

You will receive a range of new benefits and services which are exclusive to Fellows, and you will also have access to the full range of Member Services that you currently enjoy.

Fellow membership is open to anyone who has been a Full Member of Accounting Technicians Ireland for eight continuous years and who works in a senior accounting role.



# How to become a Fellow of the Institute of Accounting Technicians Ireland

You can become a Fellow of the Institute of Accounting Technicians Ireland if:

- **1.** You have been a Full Member (MIATI) for at least eight continuous years. It doesn't matter if your membership lapsed at some stage, as long as you have eight continuous years of membership before or after that period.
- **2.** You have at least five years' experience working in a senior accounting role. This experience must have been gained since you became a Full Member.

#### It can include:

- Roles where you had sole responsibility for certain tasks
- Roles where you had supervisory or managerial duties
- Roles where you undertook specialised work

Given the variety of roles that an experienced Accounting Technician can perform, we do not specify the precise work experience necessary

- **3.** You have a referee who can verify the most-recent three years of your work experience. Your referee can be your line manager, employer or a qualified accountant who has had direct knowledge of you and your work experience. The remaining two years' experience can be detailed in a CV or letter. We cannot count work experience that was gained during a period of lapsed membership.
- **4.** Your annual Membership Subscription is fully paid up at the time of application.

# How to Apply

- To apply for your Fellowship, simply complete a Fellow Membership application form and return it with a one-off fee of €55/£50.
- Your application will be assessed and successful candidates will be invited to a Conferring Ceremony in December to receive their Certificate of Fellowship.
- Fellow membership subscriptions are due in November and should be renewed every year. The cost is just €5/£5 more than the Member subscription.

# Not yet ready to apply?

- Once you meet the criteria, you can apply for Fellowship whenever you are ready to do so there is no time limit on applications, and we accept applications from July of each year.
- If you are not yet ready to apply but would like to gain FIATI status in the future, you can get a head start now by recording any senior experience you've already gained to support your application.

  This way, you won't have to approach employers at a later date.
