Additional fees (ROI and NI)

The Diploma is conferred on the successful completion of two years of study and two years of relevant work experience within an accounting or finance environment. The work experience is assessed via the Work Practice Programme which can be completed either during study or after.

The Programme is composed of two Work Practice modules which will be available to purchase in your student TouchPoint portal from September 2022.

The learning outcomes of the Work Practice module are aligned with the Year 1 curriculum. The learning outcomes of the Advanced Work Practice module are aligned with the Year 2 curriculum. Both Modules comprise of 4 tasks (8 in total), which align with the 8 core curriculum modules studied as part of the Certificate (Year 1) and Diploma (Year 2) syllabi.

The Work Practice modules have replaced the previous Record of Work Experience Document for all students commencing study for the academic year 2022 and going forward.

Students who commenced their studies prior to the 2022 academic year can choose to gain their required work experience under either the new Work Practice modules or previous Record of Work Experience Document.
